

**From Chief Troy
Bossman Knowlton**

Spring has finally arrived and with it comes change, good news and some political news for our Nation and for all First Nations people in Alberta.

First, funding for our school has been secured and we will soon be underway. Needless to say, this is a major milestone for us, for our young people and for young people generations to come. This facility will encourage learning in a setting that is modern, yet still reflects our history and culture. There were so many people responsible to making this dream a reality – I cannot name them all here. But you are all owed many thanks from our entire Nation.

Progress is being made on the opioid crisis. Let me be clear, we are nowhere near solving this problem, but we have taken real and

meaningful steps towards that goal. The curve of addiction and death is being flattened. We can all feel that I'm sure. Medical detox beds are coming, and your Council is working hard to get more resources to direct at this, our most fundamental challenge.

As you may have seen, there is a movement in Alberta to get a question on the next election ballot for the separation of Alberta from Canada. I, along with other Confederacy Chiefs and Chiefs across Alberta have been very clear with the Government of Alberta and will Albertans. The answer is "no". The Treaties mean there is no option for separation of Alberta from Canada without the consent of Treaty Nations.

Our Treaties pre-date Confederation and cannot be ignored. I will keep you posted on further political developments as they arise. Rest assured though, we will never abandon our duty to uphold our Treaty and the

obligations they impose.

As you may have seen, the Alberta Energy Regulator has approved the testing phase for the Grassy Mountain Mine. Remember, this is not approval of the mine, but only feasibility testing. We have agreed to support testing, so that we can see and reflect on the data that testing reveals. Once we have that information, we will come back to you for discussions on how Piikani should proceed to either support or oppose that project.


More major news is coming, including on potential land claim settlements. I will provide that information as soon as it becomes available.

Councilor Cynthia Provost Awarded Honorary Doctorate of Laws

Every year, Mount Royal University awards Honorary Doctor of Laws to individuals whose achievements reflect the highest ideals of leadership, service and vision. This year, Councilor Provost has earned this esteemed regard.

From Mount Royal University:


Cynthia Provost is a respected leader from Piikani First Nation who has made significant contributions to both law enforcement and Indigenous communities in Calgary and beyond.

In 1997, she became the first Blackfoot woman to join the Calgary Police Service (CPS), where she dedicated over two decades of duty and distinguished service. As the Indigenous Strategic Engagement Officer, Provost worked to build stronger relationships between the police, community and all people.

Her advocacy and volunteerism for Indigenous rights and social justice was awarded with a pinnacle career appointment to become a Member of the Order of Merit of the Police Forces, (M.O.M.), by the Chancellor's Command in 2019.

In 2023, Provost was elected into Piikani Nation leadership. Her leadership extends beyond her professional work, with past involvement in various organizations, including the City of Calgary, the Calgary Foundation, the Centre for Newcomers, the Calgary Catholic Board of Education, the Alberta Solicitor General and Public Safety, and the Alberta Human Rights Commission.

From Councilor Cynthia Provost:

Several months ago, when I learned I would be receiving this award, I was asked this question:

"Can you share a bit about your journey leading up to this point in your career or life? What experiences have been most significant?"

My answer was my journey involving my policing career was based on the foundation of hard work and personal sacrifice from my Great-Grandfather Private Napolean "Nap" Provost, PPCLI, service to Canada in WWI. Nap enlisted with the 13th Canadian Mounted Rifles arriving in England on July 5, 1916, where they were used to feed drafts in Lord Strathcona's Horse, Royal Canadian Dragoon, Fort Garry Horse, the Royal Canadian Regiment and the Princess Patricia's Canadian Light Infantry (from family records). Nap served in WWI with his older brother Charles and younger brother



Pierre "Pete" Provost.

Only Nap and Charles would return after fighting at Vimy Ridge, Passchendaele, and many other battlefields now legendary in Canadian military history.

My Great Uncle Lance Corporal Pete Provost life sacrifice at twenty-three of age, ended with the 43rd Battalion battles including MOUNT SORREL, SOMME 1916, Vimy Ridge, Hill 70, Passchendaele, Amiens, Drocourt-Queant, the Hindenburg Line and Canal du Nord, and eventually killed in action around Damery during the 100 Days campaign. Pete was awarded a Plaque and Scroll (given to families of soldiers who died during service), the Victory Medal, and the British War Medal (from family records).

In recognizing my Provost history of sacrifice for our country's ideals, to live strong and free, I felt lucky to carry this noble legacy forward as a police officer. I wanted to ensure I personally understood the meaning behind LEST WE FORGET and help to grow beyond the stories we read in school and step into a lifetime of public service to do my part in helping people.

The most profound experience I have had to date was when my Calgary Police Service partner and I were first on-scene for a 911

call. We worked together keeping the scene safe and administering CPR to save a human life. I compared this day to what my Great-Grandfather Nap and my uncles Charles and Pete and what they faced on the battlefields. That day, I felt their strength.

I was asked another question:

"What advice would you give to the next generation of students and professionals in your field?"

My answer: The advice I would give to our next generations looking to serve in policing and any first responders is that as Blackfoot and Indigenous people, We ARE Warriors. Learn from Historians such as James Dempsey, who suggests that on the plains particularly, a warrior ethic, is built from centuries of competition and conflict, and remains strong. I would say do not be afraid, our grandmothers and grandfathers have already paved the way. You need only to step into a proud legacy of service.

I am deeply honoured and humbled by this award. It is a privilege to live a life of service and I will continue to do my utmost to show up and do my part for all.



Itai'taamaopo'p Ltd.

The opening of the newly constructed Itai'taamaopo'p home in the Piikani Nation has been delayed. During preparations for the opening, Itai'taamaopo'p has encountered issues that have caused the delay in opening and provision of services.

Piikani Nation Chief and Council, along with external partners and agencies have been working diligently to ensure that the intended services remain the utmost priority.

Itai'taamaopo'p is a ten-bed home for the youth ages 13-17 years and presently in care under the Child, Youth and Family Enhancement Act.

Itai'taamaopo'p Elder & Youth engagement Sessions

In partnership with Seniors New Horizons, Itai'taamaopo'p Ltd hosted two youth and elder engagement sessions. The sessions included invited elders and students from the schools of Piikani, Fort Macleod and Pincher Creek.

Sessions were filled with stories, gifts, food, and the opportunity to have their faces painted. Students were provided the opportunity to build their own smudge boxes and learn and understand to smudge and the use of sweetgrass, sweet pine and sage.

Itai'taamaopo'p is excited to host more programs to enrich the youth of their culture, heritage and rich Piikani history and language and preserving those teachings by the knowledge of the elders.





Lands & Environment

Tree Planting in River Valley

- In 2023 Shakit by TELUS approached Piikani with through collaboration with the Piikani Lands Department on understanding sites and plants of cultural and environmental significance present to Chief and Council a restoration plan in the river valley.
- The restoration program is aimed to rehabilitate 300 hectares of the cottonwood forest in riparian zones with the River valley watershed. In 2024, the project saw 150,000 trees planted – all native species with deep root systems to mitigate erosion and safeguard the remaining cottonwood system, included as well will be aspen, willows and shrubs. Piikani Nation members were utilized for the planting of the trees employing over 30 members.
- In 2024 – Harvesting of cottonwoods were completed for fall planting approximately 150,000 seedlings for fall planting in 2025.
- 2025 – Spring planting completed 14,000 trees
- 2025 – June – 10,000 white spruce will be planted
- 2025 – September 700,000 Cottonwood, Silverberry, Chokecherry and Willow

a multi-year vision was created that would engage local the school and community in learning about food and energy security, traditional plants and methods, how to build and maintain a new community greenhouse and link programming to the rejuvenation of prairie grasslands that together will build biodiversity and adaptive capacity to a rapidly changing world.

By installing a community appropriate hydroponic growing unit and providing training for new positions in the community to operate it was identified through funding by the Piikani Lands Department to send a strong message of hope for the community towards food security as a Phase 1 – Test Project.

Currently we are seeking applications from Piikani Nation Members for this Project, we have contracted Amanda Mendes Fernandes from the Polytech Lethbridge Community College until August to assist with the Growcer.

The week of May 16 the Growcer was Commissioned, and training was provided to staff at the Piikani High School and Lands Department.

An Official Announcing for the Opening of the Growcer Unit to be announced to the Community in the upcoming months.

Residential School Search Project

The Working Group has conducted over 30 interviews with Piikani Nation Residential School Survivors and has participated in the ground search at RS site on the north side and Sacred Heart Residential School

site upcoming will be the St Cyprian's Residential School Site.

- The Working Group has participated in several open houses to the community on information sharing with the project.

1. Kamloops Indian Residential School: September 16th – 19th, 2024

- a. 29 participants attended this trip. Participants included: 16 survivors; 11 helpers & 3 staff.
- b. This trip was arranged for the survivors to become familiar with our work and how the project began (finding of 215 unmarked graves); To begin thinking and collecting ideas of how we can continue our work and commemorate the project.

2. Truth and Reconciliation Day: September 30, 2024

- a. This event was quite successful. We began the day gathering at the Community Hall. Elder Survivor, Louise English said some opening remarks about the significance of the day and offered prayers. Knowledge Keeper, Jaron Weasel Bear led with an honor song. Procession began to the Arbour, led by the Piikani Nation Volunteer Fire Fighters and Peigan Public Works.

- b. Followed was a traditional knowledge exchange filled with, a historical narrative was read while we honoured the IRS Survivors', followed by a feast and dance demonstrations.

3. Collaboration Meetings:

- a. October 30th: The Piikani Project team hosted the last collaboration meeting between Kainai and Siksika. These meetings have been helpful in navigating and sustaining the project. All nations look forward to coming together to meet and support one another.
- b. Our meetings discuss resources available, successes and challenges.

4. **Ongoing interviews will continue** and the Ground Penetrating Radar will commence again with the next coming weeks starting at St. Cyprian's Residential School Site.
5. **All information related to the project is welcome** and appreciated by Nation Members for the Research of the Project.

Keepers of the Land Project

- In 2023 the completion of Voice of Resilience was opened at the Cave n Basin in Banff National Park that included all Piikani Nation Members. These stories were displayed at the University of Lethbridge for 1.5 years. Due to the success of the project, it will be at the Cave 'n Basin for the next 2 years
- 2025 will be the completion of the Youth Voices of Resilience with students from the Piikani Nation we will showcase the project once it is completed. Project was funded by Red Cross and Resilience Institute.
- Under the authority of Chief and Council; a herd of 16 Innii were transferred to the Dip

they will be part of a grassland restoration project. 15 of the original herd will be kept at the CY Ranch they will manage the remaining herd.

- 6 Beaver Analogs were installed on the east end of the hay-lease to capture water within the existing coulee, these analogs are man-made with natural material; willows, grass etc., They are a part of a water storage project for the Nation, the funding was provided by Cows and Fish organization.
- 4 Composting Units were installed at the Piikani School and Piikani Daycare composting staff were trained to manage the units and have been well received. Funding was provided by Ecotrust Calgary

The Piikani Lands/Environment was the recipient of the Clean 50 Top Project sponsored by Delta Management Group for "Seeding our Future with Sweetgrass"

Prior to sample collection, the Piikani Nation and their community partners at the Resilience Institute, hosted a Sweetgrass Partnership Ceremony (September 9, 2022, Piikani Reserve 147 and 147B). The trans-disciplinary team of scientists from the University of Lethbridge, Agriculture and Agri-Food Canada, and the Resilience Institute and invited guests joined Elders and other knowledge holders from the Piikani Nation in a traditional tepee where Elder Peter Strikes with a Gun gave a blessing for the collaborative work and expressed how Sweetgrass represented a symbol not just of their history, but of their future (Strikes with a Gun, September 9, 2022).. Consultation & Traditional Knowledge Services

Piikani Consultation is Gearing Up for a Busy Field Season

Throughout the year Piikani Consultation meets with various companies who are planning to develop projects that are either new start-ups or are expanding their existing services. The companies come in a variety of different fields and industries and are various stages of development proposed to take place somewhere in our Ancestral territory. In all cases, Piikani Consultation assesses each project to ensure that the companies do not adversely impact Piikani's Aboriginal and Treaty Rights, irregardless if the project is near our reserve.

At the current time our office has a full time staff who work in coordination with a team of archaeologists, engineers, scientists and our own elders and knowledge keepers to conduct our studies on the land.

At the present time we are preparing for field work at two mine locations in BC. These are Elk Valley Resources who are proposing to expand their operations in the Fording River Extension Mine and NWP Resources who are proposing the development of the Crown Mountain Mine. We are also conducting an impact to Piikani Rights assessment on the Grassy Mountain Mine. We are also conducting field studies with TC Energy and smaller proponents through the summer.

Piikani Consultation is hosting a 2day community event called Piikani Days on August 11 & 12. The day will encompass Elders Stories, Traditional Games, Environmental And Cultural teachings and door prizes for all of the community to participate. More information to come.

Piikani Nation Habitat Restoration Project

Restoring Habitat for Westslope Cutthroat Trout, Bull Trout, and Lake Sturgeon

The Piikani Nation Consultation Department in collaboration with the Lands Department is restoring the habitat for Westslope Cutthroat Trout, Bull Trout, and Lake Sturgeon in our Nations territory. By combining our Indigenous knowledge, scientific expertise, and community engagement, we have selected sites that are good candidates for restoration and have

been working on them for the past two years.

The main objectives of this project are:

1. Restore and enhance the habitat of Westslope Cutthroat Trout and Bull Trout in the Oldman River watershed.
2. Identify where in the rivers these species are found and locate migration barriers.
3. Incorporate traditional ecological knowledge and practices to guide restoration efforts, recognizing the interconnectedness of land, water, and our culture.
4. Promote community involvement, capacity-building, and employment opportunities within Piikani Nation.

One of the ways we are protecting fish habitat is by installing electric fences to keep cattle out of river valleys and drainages. When cattle go down in the river valleys to feed and drink, they can trample the riverbanks and cause erosion. This soil can get into waters causing algae to grow and choking out spawning areas. Using fences to keep out cattle in strategic areas allows natural vegetation to regenerate which prevents erosion and protects water quality.

We are also helping this natural growth by planting native shrubs and trees such as willows, cottonwoods, and dogwood. We are also planting medicines and other native species such as mint, sage, sweetgrass, wild onions, saskatoons, chokecherries, and strawberries. These species were chosen based on guidance from Elders and land users who know the land well.

We are complimenting the restoration work by using eDNA monitoring to identify where trout and sturgeon are found in the Oldman River and it's tributaries. This cutting edge monitoring technique can be used to identify DNA in the environment so that we know where these important fish are found. By sampling the waters during spawning periods, we can where in the Oldman River watershed that sturgeon and trout are found.

In total we have an area of 225,931 m² that has been helped through the restoration efforts. We will be continuing to restore more habitat this year.

This project is funded by the DFO Canada Nature Fund for Aquatic Species at Risk (CNFASAR) program. This is the third and final year of the project (although we will be looking for funding to continue to build on it in the future). We will be holding a community meeting in the fall to share more information. All are welcome to come out to learn and share your knowledge!





Child & Family Services

Piikani Child and Family Services (CFS)'s Prevention Program - Koko'nnooni "Our Home" fills an essential role in our community by providing services that promote the development and well-being of Piikani children, youth, and families.

On behalf of the Piikani CFS, we invite those who access the Prevention Program - Koko'nnooni "Our Home" to work with us on our common goals, incorporating the following values:

- Mookaahksiin (Commonsense) – We will think critically and act reasonably with our children's and families' best interests in mind;
- Ainnnakowa / Inna'kotsiisins / Aain'iymma (Respect) – We are respectful of the dignity and individual nature of the people;
- Okamo'tsitiatiipi (Honesty) – We are truthful in all our decisions and actions;
- Kimmapiiyipitsini (Caring) – We are compassionate and care for our children and families;
- Ninnayawa / Akaat'sismon (Accountability) – We are responsible and accountable, in a manner that advocates for our children, family and communities.

Cultural Support Program Summary:

Our cultural support program is a culturally dedicated service for community members and families to meet, discuss, and learn on the Piikani way of life in scheduled meet-ups, lunches, and dinners.

This program includes services in cultural teachings, scheduled or public ceremonial events, and in-person discussions on the Piikani way of life.

Youth Program Summary:

To raise healthy, safe, and proud Piikani Nation Children through engaging in artistic activities, and movement that can significantly enhance physical health. As well as Blackfoot teachings, to give identity that will create belonging in our children.

We aim to nurture connections with children and families by incorporating arts, promoting physical activity, and sharing valuable insights from our elders.



- Current restoration projects intended to increase units available to Families for rent.


